**RESOLUTION NO. 93-433**

**WHEREAS, by Resolution No. 93-354 "Authorization to Continue Executive Branch Operations", the Executive Branch was given 60 days to continue Branch Operations pending the review and approval of an FY '94 Budget; and**

**WHEREAS, the Legislative Council by Legislative Order No. 93-405 did set November 24, 1993 as a special session to address the Executive Branch FY 1994 Budgets; and**

**WHEREAS, on November 24, 1993, the Executive Office was not fully prepared to present its FY 1994 Executive Program Tribal Budgets; and**

**WHEREAS, it is necessary to extend spending authorization beyond the 60 days outlined in Resolution No. 93-354; and**

**WHEREAS, it is in the best interest of the Nation that the Executive Branch be authorized to continue its fiscal operations pending the review and approval of its FY '94 budgets by the Tohono O'Odham Legislative Council.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that it does hereby extend Resolution No. 93-354 and authorizes the Executive Branch to continue**

operations, at current spending levels, in order that programs  
and services will not be interrupted.

**BE IT FURTHER RESOLVED** that this interim period is hereby extended to  
December 30, 1993.

The foregoing Resolution was passed by the Tohono O'Odham Legislative  
Council on the 24TH day of NOVEMBER, 1993 at a meeting at which a  
quorum was present with a vote of 1,473.5 FOR; 289.5 AGAINST; -0-  
NOT VOTING; and 06 ABSENT, pursuant to the powers vested in the  
Council by Section 1(d)(3) of Article VI of the Constitution of the Tohono  
O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18,  
1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,  
1934 (48 Stat. 984).




