NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Council that it does hereby recognize that the above named person has relinquished their membership in this Nation, and does hereby order that their name be deleted from the membership roll.

The foregoing Resolution was passed by the Tohono O'Odham Council on the <u>3RD.</u> day of <u>JANUARY</u>, 1994, at a meeting at which a quorum was present with a vote of <u>1,292.0 FOR</u>; <u>165.5 AGAINST</u>; <u>75.5 NOT VOTING</u>; and <u>230.0 [04] ABSENT</u>; pursuant to the powers vested in the Council by Section 3 of Article II and Article VI Section 1 (h) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
