5 WHEREAS, the Tohono O'Odham Nation recognizes the need to
6 obtain legislative and administrative advocacy services in
7 regard to programs and services of the Federal
8 Government of the United States of America; and

11 WHEREAS, the firm of Ducheneaux, Taylor & Associates - Washington,
12 DC - has continued to provide adequate services into fiscal
13 year 1994, including: to advise the Nation regarding
14 Federal initiatives; to act as liaison with the Federal
15 Executive and Legislative Branches; to arrange meetings
16 with Federal Officials; to provide specific reports on
17 services provided directly to the Nation; and

21 WHEREAS, funds in the amount of \$30,000.00 have been
22 appropriated by the Legislative Council of the Tohono
23 O'Odham Nation for the purpose of obtaining these
24 services in fiscal year 1994 Lobbyist Budget of the

NOW, THEREFORE, BE IT RESOLVED that the Legislative
Council of the Tohono O'Odham Nation hereby accepts the
proposal of Ducheneaux, Taylor & Associates to provide
services to the Nation for the period of October 01, 1993
to September 30, 1994.

BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative
Council that the Tohono O'Odham Nation's Officials, to wit:
the Chairman or any designated official are hereby
authorized to negotiate and execute the contract provided,
however, that any amendments affecting the funding or
funding levels of the contract shall be submitted for further
prior by this Council.

The foregoing Resolution was passed by the Tohono O'Odham
Legislative Council on the 6TH. day of JANUARY, 1994 at a meeting
at which a quorum was present with a vote of 1,628.0 FOR; 135.0
AGAINST; 0 NOT VOTING; and 01 ABSENT, pursuant to the powers
vested in the Council by Section 1(f) of Article VI of the Constitution of
the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation
on January 18, 1986; and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to
Section 16 of the Act of June 18, 1934 (48 Stat. 984).






