

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM COUNCIL
(Recommendation to Rescind San Xavier District
Land Use Plan)**

LEGISLATIVE ORDER NO. 94-011

WHEREAS, the Tohono O'Odham Legislative Council passed Resolution No. 93-119 "Recognizing & Confirming the Authority of the San Xavier District Council to Adopt its Land Use Plan"; and

WHEREAS, on January 7, 1994 the Chukut Kuk District Representatives presented to the Tohono O'Odham Legislative Council Chukut Kuk District Council Resolution #94-10, titled "Rescinding the San Xavier Land Use Plan & Moving Operation on Tribal Lands"; and

WHEREAS, the Chukut Kuk District Council resolution cited, "concern about the decentralization of the legislative authority and that such plan has bottle-necked the distribution of gaming revenues and other issues stemming from the Desert Diamond Casino"; and

WHEREAS, the Chukut Kuk District Council recommended that the Tohono O'Odham Legislative Council rescind the San Xavier District Land Use Plan and urged the Tohono O'Odham Legislative Council to move the gaming operation of the Desert Diamond Casino to tribal lands within the San Xavier District; and

4 **letter requesting the opportunity to have the Districts**
5 **meet and discuss the concerns raised by the Chukut Kuk**
6 **District Council.**

8 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'Odham**
9 **Legislative Council that the issues raised in Chukut Kuk**
10 **District Council Resolution #94-10 be addressed by the**
11 **District Councils of San Xavier and Chukut Kuk.**

13 **BE IT FURTHER ORDERED that if this issue is not resolved it will be**
14 **brought back to the Tohono O'Odham Legislative**
15 **Council.**

18 **The foregoing Order was passed by the Tohono O'Odham Legislative**
19 **Council on the 7TH. day of JANUARY, 1994 at a meeting at which a**
20 **quorum was present with a vote of 1,102.5 FOR; 472.0 AGAINST;**
21 **188.5 NOT VOTING; and 03 ABSENT, pursuant to the powers vested**
22 **in the Council by Section 1(a) of Article VI of the Constitution of the**
23 **Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on**
24 **January 18, 1986; and approved by the Acting Deputy Assistant**
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to**
26 **Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


