5 resolution #93-355 the Gu Achi District FY 94 Budget, in

8 WHEREAS, an appropriation of \$88,182.38 was made from the
9 Special Reserve Account to support the Gu Achi District
10 FY 94 budget; and

13 WHEREAS, in order to avoid disruption in services provided by the
14 district, the Gu Achi District Council desires to have the
15 tribal support dollars in the amount of \$88,182.38
16 deposited into their account #20285576, First American
17 Credit Union in Casa Grande, Arizona.

20 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
21 Council that it hereby approves and authorizes the
22 transfer of funds in the amount of \$88,182.38 as
23 requested by the Gu Achi District Council (to be expended

25 #93-355).

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 7TH day of JANUARY, 1994 at a meeting at which a quorum was present with a vote of 1,763.0 FOR; 0 AGAINST; 0 NOT VOTING; and 04 ABSENT, pursuant to the powers vested in the Council by Section 1(d) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).







approve or disapprove it within 48 hours of submittal.


