RESOLUTION NO. 94-017

WHEREAS, the Tohono O'odham Nation is a federally recognized Indian Tribe pursuant to the provisions of the Indian Reorganization Act of 1934; and

WHEREAS, the Tohono O'odham Legislative Council was apprised of the established rodeo organization, known as Southwest Indian Rodeo Association (SWIRA); and

WHEREAS, the intent of the Southwest Indian Rodeo Association (SWIRA) is to establish Southern Arizona as a separate region of the Indian National Finals Rodeo to provide equal representation to all 22 Indian tribes in Arizona; and

WHEREAS, the Tohono O'odham Legislative Council supports the intention of Southwest Indian Rodeo Association.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby supports the Southwest Indian Rodeo Association's (SWIRA) intent to establish Southern Arizona as a separate region to represent all 22 tribes in the State of Arizona.

Legislative Council on the 7TH. day of JANUARY, 1994 at a meeting
at which a quorum was present with a vote of 1,763.0 FOR; 0
AGAINST; 0 NOT VOTING; and 05 ABSENT, pursuant to the powers
vested in the Council by Section 1(I) of Article VI of the Constitution of
the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation
on January 18, 1986; and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to
Section 16 of the Act of June 18, 1934 (48 Stat. 984).




