Council that it does hereby recognize that the above

membership in this Nation, and does hereby order
that their name(s) be deleted from the membership
roll.**

Council on the 8TH. day of FEBRUARY, 1994, at a meeting at
which a quorum was present with a vote of 1,497.0 FOR; 115.0
AGAINST; 151.0 NOT VOTING; and 03 ABSENT; pursuant to the
powers vested in the Council by Section 3 of Article II and Article
VI Section 1 (h) of the Constitution of the Tohono O'Odham
Nation, adopted by the Tohono O'Odham Nation on January 18,
1986; and approved by the Acting Deputy Assistant Secretary -
Indian Affairs (Operations) on March 6, 1986, pursuant to Section
16 of the Act of June 18, 1934 (48 Stat. 984).**
