

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving TOUA Utility Easement Well Site & Water  
Line, Crowhang Community)**

**RESOLUTION NO. 94-030**

**WHEREAS, the Tohono O'Odham Utility Authority proposes to construct a new Water Transmission Line and Well Site to furnish water facilities and other related utility services to the Crowhang Community of the Schuk Toak District and has submitted a plat or map thereof to the Tohono O'Odham Council showing the location and scope of the easement and delineating the utility facilities to be placed thereon; the length of the line in the Crowhang Community is 3426.79' x 40' wide. The Schuk Toak District Council also approves allocation of property for a Well Site which is 100' x 100' as set forth on the attached drawings; and**

**WHEREAS, the Tohono O'Odham Council has determined that the routing and location of the easement is not in conflict with any land use plans adopted by the District Council and approved by the Tohono O'Odham Council, and that the Water Transmission Line and Well Site will be of substantial benefit to the Crowhang Community, Schuk Toak District, and the**

Indian Affairs (Operations) on March 6, 1986, pursuant to Section  
16 of the Act of June 18, 1934 (48 Stat. 984).**






