RESOLUTION NO. 94-033

**WHEREAS, the Legislative Council is the governing body of the
Tohono O'Odham Nation; and**

**WHEREAS, the Legislative Council has always viewed the health
care of the women and children of the Nation as a
priority; and**

**WHEREAS, the lack of early intervention of prenatal care to
O'Odham mothers, and similarly, the lack of early
well-child care to O'Odham children represents a
major health concern of the Nation for its women
and children; and**

**WHEREAS, the Arizona Department of Health and Human
Services has offered Maternal Child Health (MCH)
Block Grants funds state-wide with specific concerns
of proposed service recipients being African
American, and Native American families; and**

**WHEREAS, the Legislative Council recognizes this is only a
proposal to receive these specific MCH Block Grant
funds; and**

**WHEREAS, the Legislative Council recognizes that if a grant is
awarded, then further negotiations will take place
before any legal binding contract is signed; and**

**WHEREAS, this project has the tremendous potential of affecting
pregnant and postpartum O'Odham women's health
and the children that live with them, thereby,
affecting the next O'Odham generation in a very
positive way.**

**NOW, THEREFORE, BE IT RESOLVED that the Legislative Council
approves and endorses the Nation's participation in
the submission of a Proposal 5-517, to develop and
implement, a Neighborhood Outreach Program
offered by the Arizona Department of Health and
Human Services utilizing Maternal Child Health
Block Grant funds.**

**BE IT FURTHER RESOLVED that the Chairman or his designated
agent is hereby authorized to sign and execute such
documents as may be required to fulfill the intent of
this resolution.**

**BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative

to wit: the Chairman and any designated official are
hereby authorized to negotiate and execute the
proposal, provided however, that any awarded
contract shall be submitted for further prior
approval by this Council.**

Legislative Council on the 10TH day of FEBRUARY, 1994 at a
meeting at which a quorum was present with a vote of 1,763.0
FOR; -0- AGAINST; -0- NOT VOTING; and 05 ABSENT, pursuant
to the powers vested in the Council by Section 1(c)(2) & (f) of
Article VI of the Constitution of the Tohono O'Odham Nation,
adopted by the Tohono O'Odham Nation on January 18, 1986; and
approved by the Acting Deputy Assistant Secretary - Indian Affairs
(Operations) on March 6, 1986, pursuant to Section 16 of the Act
of June 18, 1934 (48 Stat. 984).**






