**WHEREAS, the Tohono O'Odham Nation is presently operating
the JTPA Title IIA Program under FY 1994 Contract
with the State of Arizona Department of Economic
Security; and**

**WHEREAS, any amendments affecting the funding or funding
levels of the contract shall be submitted for review
and approval by the Tohono O'Odham Legislative
Council; and**

**WHEREAS, an amendment has been submitted to reflect the
decrease in the appropriation for the JTPA Title IIA
ACP/Program of \$4,168.00 to reflect calendar year
1994 Final Allocation in the total amount of \$130,855.**

ACP - \$648.00

Program - \$3,510.00

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham
Legislative Council does hereby approve the
amendment to the JTPA Title IIA ACP/Program and**

contract, provided however, that any amendments
affecting the funding or funding levels of the contract
shall be submitted for further prior approval by this
Council.

Legislative Council on the 10TH. day of FEBRUARY, 1994 at a
meeting at which a quorum was present with a vote of 1,583.0
FOR; -0- AGAINST; -0- NOT VOTING; and 180.0 [08] ABSENT,
pursuant to the powers vested in the Council by Section 1(f) of
Article VI of the Constitution of the Tohono O'Odham Nation,
adopted by the Tohono O'Odham Nation on January 18, 1986; and
approved by the Acting Deputy Assistant Secretary - Indian Affairs
(Operations) on March 6, 1986, pursuant to Section 16 of the Act
of June 18, 1934 (48 Stat. 984).




