Council; and**

**WHEREAS, an amendment has been submitted to reflect the
decrease in the appropriation for the JTPA Title IIC
ACP/Program/Employment and Training Program of
\$2,904.00 to reflect calendar year 1994 final
allocation in the total amount of \$88,111.00**

Program - \$2,445.00

(Operations) on March 6, 1986, pursuant to Section 16 of the Act
of June 18, 1934 (48 Stat. 984).**
