the amount of \$103,591.00 for the JTPA Title IV  
Employment and Training Program for Calendar Year  
1994; and**

**WHEREAS, any amendments affecting the funding or funding  
levels of the grant shall be submitted for review and  
approval by the Tohono O'Odham Legislative Council;  
and**

**WHEREAS, an amendment has been submitted to reflect an  
increase in the amount of \$103,591.00 for review and  
approval by the JTPA Title IV Employment and  
Training Program to reflect Calendar Year 1994  
amount of \$532,463.00**

14 **provided however, that any amendments affecting**  
15 **the funding or funding levels of the grant shall be**  
16 **submitted for further prior approval by this Council.**

25 **pursuant to the powers vested in the Council by Section 1(f) of**  
26 **Article VI of the Constitution of the Tohono O'Odham Nation,**  
27 **adopted by the Tohono O'Odham Nation on January 18, 1986; and**  
28 **approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
**(Operations) on March 6, 1986, pursuant to Section 16 of the Act**  
**of June 18, 1934 (48 Stat. 984).**




