11 **Resolution No. 45-90, reflecting \$44,085.00, to the**

15 **the planning and design of the juvenile detention**
16 **and rehabilitation center; and**

18 **WHEREAS, approval of the budget is critical to the beginning of**
19 **the planning and design of the proposed juvenile**
20 **detention and rehabilitation center; and**

22 **WHEREAS, the Tohono O'Odham Judiciary was allocated**


