WHEREAS,	the Tohono O'Odham Nation ("Nation") suffers from a number of illnesses and diseases including, but not limited to alcoholism,					
	diabetes mellitus, Human Immunodeficiency Virus					
	(HIV)/Acquired Immunodeficiency Disease Syndrome (AIDS),					
	tuberculosis and a lack of emergency medical services and basic					
	transportation; and					

WIIEREAS,	the Nation, through its health and social services departments
	offers programs concerned with the delivery of services which
	addresses the illnesses and diseases afflicting the Nation; and
WHEREAS,	present staffing and funding for delivery of such services is

inadequate to meet the high demand of patients and clients suffering from these conditions and the continuing rise in the number of patients and clients needing services; and

WHEREAS, Indian Health Services (IHS) has been directed to implement FTE ceiling and administrative budget cuts which further impacts on already inadequate staffing and resources to fully meet the demand and rise in the incidence of the Nation's illness and disease; and

WHEREAS, it is the desire of the Nation to address the many health needs of its members.
