and beneficial to the Tohono O'Odham Nation and its  
people; and**

**WHEREAS, O'Odham children are entitled to Child Protective  
Services and additional resources are needed to  
provide adequate services; and**

**WHEREAS, the Tohono O'Odham Nation, Social Service is eligible  
to apply for special Congressional Appropriations for  
departmental activities.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham  
Legislative Council is in support of the request of the  
Tohono O'Odham Social Service Department as herein  
stated.**

**BE IT FURTHER RESOLVED that the Tohono O'Odham Legislative  
Council authorizes the Tohono O'Odham  
Appropriations Committee to submit this request in**

the amount of \$156,218.00 to the appropriate members and committees of Congress.






