4 **Nation borders on the United States/Mexican International**
5 **Boundary; and**

7 **WHEREAS, there has been continuous problems of cattle rustling drug**
8 **trafficking and illegal entry of foreign nationals into the United**
9 **States; and**

11 **WHEREAS, the Tohono O'odham Nation's Police Force is extremely limited**
12 **in manpower and funds to cover the vast area within its**
13 **boundaries including the International United States/Mexican**
14 **Boundary.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham**
17 **Legislative Council does hereby request that Congress**
18 **appropriate \$1,065,834.00 in accordance with the attached**
19 **Ranger Proposal.**

22 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council**
23 **that the appropriate officers of the Nation are hereby authorized**
24 **and directed to bring this request to the appropriate members**
25 **and committees of Congress.**




