**WHEREAS, as a result of a Memorandum of Agreement between
the Indian Health Service, the Tohono O'Odham Utility
Authority and the Tohono O'Odham Nation, entered
into October 11, 1991, two community water wells and
a powerline have been constructed; and**

**WHEREAS, this Project is now complete and is of great benefit to
the Pisinemo, Nestors and Santa Cruz Villages; and**

**WHEREAS, the Tohono O'Odham Constitution requires affirmative
action by the Legislative Council to "acquire property,
transfer or convey assets to the Tohono O'Odham
Nation", (Article VI, Section 1 (i) (3) and (5).**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham
Legislative Council that the Tohono O'Odham Nation
accepts transfer of two community water wells and a
powerline constructed pursuant to IHS Project No.
TU-91-474 which will be operated, maintained and
repaired by the Tohono O'Odham Utility Authority,
and further authorizes the Chairman of the Tohono**

O'Odham Nation to execute the Transfer Agreement in the form attached hereto.


