**WHEREAS, as a result of a Memorandum of Agreement between
the Indian Health Service, the Tohono O'Odham Utility
Authority and the Tohono O'Odham Nation, entered
into November 5, 1992, water service meters have been
installed in ten homes in the Pan Tak Village; and**

**WHEREAS, this Project is now complete and is of great benefit to
ten households in Pan Tak; and**

**WHEREAS, the Tohono O'Odham Constitution requires affirmative
action by the Legislative Council to "acquire property,
transfer or convey assets to the Tohono O'Odham
Nation", (Article VI, Section 1 (i) (3) and (5).**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham
Legislative Council that the Tohono O'Odham Nation
accept transfer, on behalf of ten households, water
meters constructed pursuant to IHS Project No.
TU-92-635, which will be maintained and repaired by
the head of each of the ten households where said
meters were installed, and further authorizes the**

attached hereto.**


**The foregoing Resolution was passed by the Tohono O'Odham




