**RESOLUTION NO. 94-069**

**WHEREAS, the Bureau of Indian Affairs funding has been  
inadequate to fully fund the educational program on  
the Tohono O'Odham Nation, Bureau of Indian Affairs  
Schools; and**

**WHEREAS, continued reductions in staff and programs will result  
in fewer and lower quality educational opportunities  
for O'Odham children.**

**NOW, THEREFORE, BE IT RESOLVED that the Bureau of Indian  
Affairs re-examine the costs of small schools.**

**BE IT FURTHER RESOLVED that the Bureau of Indian Affairs re-  
examine the increase in teacher salaries based on the  
Department of Defense schedule.**

**BE IT FURTHER RESOLVED that the Bureau of Indian Affairs  
provide Indian School Equalization Program funds  
(ISEP) for the 1994-95 school year in the amount of  
\$5299 per weighted student unit.**

**BE IT FINALLY RESOLVED that the appropriate officers of the  
Nation are hereby authorized and directed to bring  
this request to the appropriate members and  
committees of Congress.**
