	Apache Indian Reservation against her wishes; and

WHEREAS, the Nation's Executive Office and Judiciary assisted Mrs.

Pablo in an attempt to resolve this issue prior to the burial and travelled with the Pablo Family to meet with the San Carlos Apache Tribal Government, which opted to take a "neutral" position on this issue; and

Mrs. Pablo requested the assistance of the Legislative Council in obtaining legal counsel to represent her in her efforts to have her son's body transferred from the San Carlos Apache Indian Reservation to the Tohono O'Odham Nation for burial in accordance with O'Odham culture and traditions; and

WHEREAS, this is an issue which involves the respect and recognition given the Nation's culture and traditions by other Indian tribes as well as other non-Indian communities and governments; and
