WHEREAS, a long-term commitment is required to justify creation of a GIS System, the grant request fully funds necessary hardware and software and the direct salary costs of personnel for the first three years of operation.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham

Legislative Council hereby authorizes application for a

Planning Grant of \$223,930., to fund creation and the first

three years of operation of a Tohono O'Odham

Geographic Information System.
