3 **WHEREAS, the Tohono O'Odham Nation is presently operating the**
4 **Tohono O'Odham Youth Services Program under an**
5 **agreement with United Way of Tucson; and**

6 **WHEREAS, such services for the youth have been successful and**
7 **beneficial; and**

9 **WHEREAS, the Tohono O'Odham Nation does desire to enter into an**
10 **agreement for services during FY 1995; and**

11 **WHEREAS, the Tohono O'Odham Youth Services/Juvenile**
12 **Delinquency has submitted a budget for review and**
13 **approval by the Tohono O'Odham Legislative Council.**

15 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham**
16 **Legislative Council that it does support and authorize the**
17 **Tohono O'Odham Nation to enter into an agreement with**
18 **United Way of Tucson for Juvenile Delinquency.**

20 **BE IT FURTHER RESOLVED that the duration of the Agreement will be**
21 **from July 01, 1994 through June 30, 1995.**

23 **BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council**
24 **that the Tohono O'Odham Nation's Officials, to wit: the**
25 **Chairman and any designated official are hereby**
26 **authorized to negotiate and execute the agreement,**
27 **provided however, that any amendments affecting the**

**funding or funding levels of this agreement shall be
submitted for further prior approval by this Council.**

**The foregoing Resolution was passed by the Tohono O'Odham
Legislative Council on the 9TH day of MARCH, 1994 at a meeting at
which a quorum was present with a vote of 1,639.0 FOR; -0-
AGAINST; -0- NOT VOTING; and 124.0 [07] ABSENT, pursuant to the
powers vested in the Council by Section 1(f) of Article VI of the
Constitution of the Tohono O'Odham Nation, adopted by the Tohono
O'Odham Nation on January 18, 1986; and approved by the Acting
Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,
1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**




