19 **proposed contract for FY 1995 Title XX - Child Day Care**

22 **BE IT FURTHER RESOLVED that the duration of the contract will be**
23 **from July 01, 1994 through June 30, 1995.**



funding or funding levels of this contract shall be
submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'Odham
Legislative Council on the 10TH day of MARCH, 1994 at a meeting at
which a quorum was present with a vote of 1,635.0 FOR; -0-
AGAINST; -0- NOT VOTING; and 128.0 [08] ABSENT, pursuant to the
powers vested in the Council by Section 1(f) of Article VI of the
Constitution of the Tohono O'Odham Nation, adopted by the Tohono
O'Odham Nation on January 18, 1986; and approved by the Acting
Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,
1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).






