

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 1994 Budget for the Tohono O'odham
Executive Branch and Appropriating Funds in
the Amount of \$3,287,095.00)**

RESOLUTION NO. 94-103

**WHEREAS, the Tohono O'odham Legislative Council appropriated
\$3,273,429.00 by Resolution No. 93-445 for the first six
months of FY 94 which expires on March 31, 1994; and**

**WHEREAS, the continued operation of the programs and
departments of the Executive Branch of the Tohono
O'odham Nation requires adoption of the remaining
six month operating budget, the grant of spending
authority, and the appropriation of funds for FY 1994;
and**

**WHEREAS, the Executive Branch of the Nation has prepared and
presented a budget that reflects the needs of the
Branch according to the first six (6) month budget
passed by Resolution No. 93-445.**

**NOW, THEREFORE, BE IT RESOLVED by the Legislative Council of the
Tohono O'odham Nation that it recognizes that payroll
taxes for Executive Branch employees in the amount
of 10% of the budgeted salaries are included in this
budget.**

**BE IT FURTHER RESOLVED that funds in the amount of
\$3,287,095.00 are appropriated and authorized to be**

expended from the sources of funding approved by this Council for support of the FY 1994 budgets of the Tohono O'odham Nation, including a nine month budget for Tohono O'odham Gaming Office in the amount of \$523,139.

BE IT FINALLY RESOLVED that the amount of \$3,287,095.00 is hereby appropriated for the remaining FY 94 Executive Budget from April 1, 1994 through September 30, 1994.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 28TH day of MARCH, 1994 at a meeting at which a quorum was present with a vote of 1,406.0 FOR; 197.0 AGAINST; 62.0 NOT VOTING; and 98.0 [03] ABSENT, pursuant to the powers vested in the Council by Section 1(d) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


