

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL

RESOLUTION NO. 94-105

WHEREAS, the Legislative Council of the Tohono O'Odham Nation is authorized by the Tohono O'Odham Constitution Article VI, Powers of the Tohono O'Odham Council, Section 1.d.3, Paragraph 3 of d asserts: to adopt, approve and amend annual budgets and to authorize the expenditure of funds in accordance with these budgets; and

WHEREAS, through research and consultation provided by the Personnel Department Director, the Budget & Finance Committee recommends that the Nation's officials and employees would benefit from a 6% cost of living adjustment to keep pace with inflation and employment practices in the general area of the Nation.

NOW, THEREFORE, BE IT RESOLVED that the Legislative Council of the Tohono O'Odham Nation hereby approves a 6% cost of living adjustment for the Nation's officials and employees effective October 01, 1994 for the Nation's Fiscal Year 1995.

BE IT FURTHER RESOLVED that the Executive Branch of the Nation is to advise that all budgets prepared and submitted to this Legislative Council for FY 1995 appropriations should include this 6% Cost of Living Adjustment and


