7 **Reservations dated January 1, 1937 and of the San Xavier**
8 **Reservation dated January 1, 1940, subject to the**
9 **approval of the Secretary of the Interior; and**

12 **WHEREAS, the Enrollment Committee has determined that the**
13 **following named person(s) were members of the Tohono**
14 **O'Odham Nation on the date of the respective census rolls**
15 **but that their name(s) had been inadvertently omitted**
16 **therefrom, and had recommended that their name(s) be**

21 **recommendations of the Enrollment Committee and**
