**WHEREAS, the Tohono O'Odham Nation is presently operating the
Rehabilitation and Aftercare Program under FY 1994**

P. L. 93-638 contract with the Indian Health Services; and

**WHEREAS, any amendments affecting the funding levels of the
contract shall be submitted for review and approval by
the Tohono O'Odham Legislative Council; and**

**WHEREAS, a budget modification has been submitted for review
and approval by the Rehabilitation and Aftercare
Component.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham
Legislative Council that it does hereby approve the
amendment to the Rehabilitation and Aftercare Budget
and requests Indian Health Services to incorporate the
said budget into the Behavioral Health Services Contract
- No. 249-94-0003.**

**BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative
Council that the Tohono O'Odham Nation's Officials, to
wit: the Chairman and any designated official are
hereby authorized to negotiate and execute the contract,
provided, however that any amendments affecting the**


