Community Based Prevention Training Project under FY
1994 P. L. 93-638 contract with the Indian Health
Services; and**

**WHEREAS, any amendments affecting the funding levels of the
contract shall be submitted for review and approval by
the Tohono O'Odham Legislative Council; and**

**WHEREAS, an amendment has been submitted for review and
approval by the Community Based Prevention Training
Project component.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham
Legislative Council that it does hereby approve the
amendment to the Community Based Prevention
Training Program Budget and requests Indian Health
Services to incorporate the said budget into the
Behavioral Health Services Contract - No. 249-94-0003.**


**BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 4TH day of APRIL, 1994 at a meeting at which a quorum was present with a vote of 1,665.0 FOR; -0- AGAINST; -0- NOT VOTING; and 98.0 [08] ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
