**WHEREAS, the Tohono O'Odham Nation is presently operating the
Tohono O'Odham Psychological Services Program (TOPS)
under an FY 1994 P. L. 93-638 contract with the Indian
Health Services; and**

**WHEREAS, any amendments affecting the funding or funding levels
of the contract shall be submitted for review and
approval by the Tohono O'Odham Legislative Council;
and**

**WHEREAS, an amendment has been submitted for review and
approval by the TOPS Program.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham
Legislative Council that it does hereby approve the
amendment to the TOPS Program Budget and requests
Indian Health Services to incorporate the said budget
into the Psychological Services Contract - No.
249-94-0004.**

**BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative
Council that the Tohono O'Odham Nation's Officials, to
wit: the Chairman and any designated official are
hereby authorized to negotiate and execute the contract,
provided, however that any amendments affecting the**

funding or funding levels of this contract shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 5TH day of APRIL, 1994 at a meeting at which a quorum was present with a vote of 1,665.0 FOR; -0- AGAINST; -0- NOT VOTING; and 98.0 [09] ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
