9 **importance of the Head Start Program; and**

10 **WHEREAS, the Head Start Program has been successful in**
11 **improving the lives of many low-income children and**
12 **their families, there continues to be a large unmet need**
13 **for services; and**

15 **WHEREAS, the current federal regulations, guidelines and eligibility**
16 **requirements governing Head Start, limits the service**
17 **delivery needs of our Indian children and families; and**

19 **WHEREAS, Tohono O'Odham Legislative Council has reviewed the**
20 **eleven critical issues affecting the Indian Head Start**
21 **Programs.**


The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 5TH day of APRIL, 1994 at a meeting at which a quorum was present with a vote of 1,665.0 FOR; -0- AGAINST; -0- NOT VOTING; and 98.0 [08] ABSENT, pursuant to the powers vested in the Council by Section 1(j) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


