## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Approving TOUA Utility Easement Serving Santa Rosa Ranch and Sil Nakya Communities)

RESOLUTION NO. 94-129

WHEREAS, the Tohono O'Odham Utility Authority proposes to construct a new transmission line and other utility services to the communities of Santa Rosa Ranch and Sil Nakya of the Schuk Toak District, and has submitted a plat or map thereof to the Tohono O'Odham Legislative Council showing the location and scope of the easement and delineating the utility facilities to be placed thereon; and the total length of the line for both the Santa Rosa Ranch/Sil Nakya Waterline is 59,025' in length x 40' in width and 5.49 acres in size (or area); and

WHEREAS, the Tohono O'Odham Legislative Council has determined that the routing and location of the easement for the new transmission line facilities and other utility services is not in conflict with any land use plans adopted by the District Council and approved by the Tohono O'Odham Council, and that the new transmission line will be of substantial benefit to the communities of Santa Rosa Ranch and Sil Nakya, Schuk Toak District, Tohono O'Odham Nation and to their respective members.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does hereby approve the easement
