

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY 1994 Elderly Program - Supplemental Security Income
January 01, 1994 - June 30, 1994)**

RESOLUTION NO. 94-136

**WHEREAS, the Tohono O'Odham Nation has successfully operated
a program for the elderly members of the Nation; and**

**WHEREAS, funding for the operation of the Elderly Program has
been possible in part by Title III of the Older American's
Act of 1965 as amended; and**

**WHEREAS, the Elderly Program has been informed that funding is
available in the amount of \$8,467.00; and**

**WHEREAS, the Elderly Program has developed and submitted a
proposal to the Inter-Tribal Council of Arizona, Inc; and**

**WHEREAS, the Elderly proposal will benefit elderly members of the
Tohono O'Odham Nation by providing a method of
seeking frail, blind, handicapped and elderly, as well as
handicapped individuals for potential supplemental
security income eligibility.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham
Legislative Council that it does hereby approve the
proposal for funding of the Elderly Program to provide
services to eligible members of the Tohono O'Odham
Nation.**

**BE IT FURTHER RESOLVED that the term of this grant shall
commence on January 01, 1994 and end on June 30, 1994.**

BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation's Officials, to wit: the Chairman and any designated official are hereby authorized to negotiate and execute the grant, provided however, that any amendments affecting the funding or funding levels of the grant shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 7TH day of APRIL, 1994 at a meeting at which a quorum was present with a vote of 1,763.0 FOR; -0- AGAINST; -0- NOT VOTING; and 07 ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




