**WHEREAS, the Tohono O'Odham Nation has successfully operated  
a program for the elderly members of the Nation; and**

**WHEREAS, funding for the operation of the Elderly Program has  
been possible in part by Article VI of the Older  
American's Act of 1965 as amended; and**

**WHEREAS, the Elderly Program desires to seek continued funding  
by submitting a proposal to the Office of Human  
Development Services, Administration on Aging for FY  
1995 in the amount of \$71,007.00; and**

**WHEREAS, the Elderly proposal will benefit elder members of the  
Tohono O'Odham Nation by providing for their  
nutritional and social support services.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham  
Legislative Council that it does hereby approve the  
proposal for continued funding of the Elderly Program  
to provide services to eligible members of the Tohono  
O'Odham Nation.**

**BE IT FURTHER RESOLVED that the term of this grant shall  
commence on April 01, 1994 and end on March 31, 1995.**
