

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Partial Waiver of Indirect Cost for the Equal Employment
Opportunity Commission)**

RESOLUTION NO. 94-141

**WHEREAS, the Tohono O'Odham Nation established a policy to
require the inclusion of indirect costs in all third party
funded agreements; and**

**WHEREAS, the policy provided for an exception and waiver of the
requirement by the Legislative Council if it is in the best
interest of the Nation to do so, that is when the benefits
to the Nation exceeds the need to collect the revenues
from the funding agency; and**

**WHEREAS, funding from the U. S. Equal Employment Opportunity
Commission for the FY 1994 Equal Employment
Opportunity Commission/TERO Program is insufficient
to cover both direct and indirect cost needs of the
program; and**

**WHEREAS, the Tribal Employment Rights Office is requesting that
a partial waiver of the Indirect Cost in the amount of
\$3,062., be waived.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham
Legislative Council finds that it is in the best interest of
the Nation to partially waive the indirect cost funding
requirement for FY 1994 Equal Employment Opportunity
Commission.**

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 8TH day of APRIL, 1994 at a meeting at which a quorum was present with a vote of 927.5 FOR; 328.0 AGAINST; 75.5 NOT VOTING; and 432.0 [11] ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
