

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM COUNCIL  
(Adopting Legislative Calendar for  
June 06, 1994 - June 2, 1995)**

**LEGISLATIVE ORDER NO. 94-155**

**WHEREAS, the Policies and Procedures of the Tohono O'odham  
Council in Article I, Section 1.A, LEGISLATIVE CALENDAR,  
Subsections 1 & 3 states:**

**1. Prior to an official adjournment, the Legislative  
Council shall adopt a Legislative Calendar which  
shall commence on the first working day of June  
on which the Legislative Council will be called into  
Legislative Session. The Calendar shall specify  
dates for the general sessions, recess periods,  
recognized holidays, and the days of adjournment.**

**3. The Legislative Calendar shall be based only on  
working days and scheduled paid holidays; and**

**WHEREAS, the Rules Committee has prepared a Legislative  
Calendar in accordance with the Policies and  
Procedures of the Tohono O'odham Legislative Council.**

**NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham  
Legislative Council does hereby adopt the Legislative  
Calendar which commences on June 6, 1994 and ends on  
June 2, 1995.**

**The foregoing Order was passed by the Tohono O'Odham Legislative  
Council on the 2ND. day of MAY, 1994 at a meeting at which a  
quorum was present with a vote of 1,533.0 FOR; -0- AGAINST; -0-  
NOT VOTING; and 230.0 [07] ABSENT, pursuant to the powers vested  
in the Council by Section 1(a) of Article VI of the Constitution of the  
Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on  
January 18, 1986; and approved by the Acting Deputy Assistant  
Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to  
Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


