WHEREAS, TOUA requests permission to expand its land assignment by approximately 1.65 acres (as described in the maps, legal description and documents attached hereto and incorporated herein by reference), to accommodate above-ground gas and diesel tanks in compliance with federal regulations and other uses consistent with the authorized purposes of TOUA; and

WHEREAS, the Sells District Council approved the requested land
