WHEREAS,	there is a concern for the O'odham residing in Mexico

WHEREAS, there have been ongoing discussions to obtain the expertise of Mr. Peter Schey and the Center for Human Rights and Constitutional Law to assist the Nation in resolving the O'odham in Mexico issues; and

WHEREAS, in order for Mr. Schey to consider the Nation's request, it is necessary for the Nation to identify the issues and concerns regarding the O'odham in Mexico.

NOW, THEREFORE, BE IT ORDERED by the Tohono O'Odham Legislative Council that it hereby sets the date of Monday, May 23, 1994 for a Special Council meeting to identify the O'odham in Mexico issues which will be forwarded to Mr. Peter Schey and the Center for Human Rights and Constitutional Law.

The foregoing Order was passed by the Tohono O'Odham Legislative Council on the <u>02nd</u> day of <u>MAY</u>, <u>1994</u> at a meeting at which a quorum was present with a vote of <u>1,257.0</u> FOR; <u>276.0</u> AGAINST; <u>-0-NOT VOTING</u>; and <u>230.0 [07]</u> ABSENT, pursuant to the powers vested in the Council by Section <u>1(a)</u> of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
