4 **WHEREAS, on Wednesday, May 4, 1994 the Tohono O'Odham**
5 **Legislative Council discussed a written request from the**
6 **Nation's Chairman to schedule a Special Session to**
7 **address the Nation's FY 95 Contract Proposals on May 24**
8 **& 25, 1994; and**

10 **WHEREAS, the FY 95 Contract Proposals are due at the funding**
11 **agencies on June 1, 1994 and that failure to submit them**
12 **could jeopardize continued funding for the Nation's**
13 **Programs; and**

15 **WHEREAS, it was stated that the Nation could, as it has in the past,**
16 **request for an extension of the deadline date for**
17 **submittal of the FY '95 Proposals; and**

19 **WHEREAS, various committees commented that they already**
20 **reviewed the FY '95 Proposals and were concerned about**
21 **the status of those budgets and questioned why they had**
22 **not been forwarded to the Council; and**

24 **WHEREAS, concerns were raised about setting the meeting dates**
25 **and the possibility of the Executive Office not being**
26 **prepared to present the budgets for review; and**

Proposals at the June General Session; and**


**WHEREAS, it was noted that there was no one present from the

**NOW, THEREFORE, BE IT ORDERED that the Tohono O'Odham
Legislative Council hereby sets the dates of May 24 & 25,
1994 for Special Council Sessions to review the FY 1995
638 Contract Proposals.**

**The foregoing Order was defeated by the Tohono O'Odham
Legislative Council on the 4TH. day of MAY, 1994 at a meeting at
which a quorum was present with a vote of 298.0 FOR; 1,243.0
AGAINST; 124.0 NOT VOTING; and 98.0 [07] ABSENT, pursuant to the
powers vested in the Council by Section 1(a) of Article VI of the
Constitution of the Tohono O'Odham Nation, adopted by the Tohono
O'Odham Nation on January 18, 1986; and approved by the Acting
Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,
1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


