

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Commerce Committee Six Month Budget)**

RESOLUTION NO. 94-170

WHEREAS, the Commerce Committee has submitted a budget for consideration by the Tohono O'odham Legislative Council for purposes of attending meetings with the State, National Indian Gaming Association (NIGA), and other Indian gaming related conferences and/or meetings; and

WHEREAS, the Commerce Committee Six Month budget submitted in the amount of \$10,000 is effective May 01, 1994 to November 30, 1994; and

WHEREAS, the budget will be made part of the Operating Expense of the Gaming Hall.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby approves the Commerce Committee Six Month budget in the amount of \$10,000.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 6TH. day of MAY, 1994 at a meeting at which a quorum was present with a vote of 1,763.0 FOR; -0- AGAINST; -0- NOT VOTING; and 05 ABSENT, pursuant to the powers vested in the Council by Section 1(d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
