3 **WHEREAS, the Tohono O'Odham Nation is presently operating the**
4 **Higher Education Program under FY 1994 P. L. 93-638**
5 **contract with the Bureau of Indian Affairs; and**

6 **WHEREAS, such tribal operations have been successful and**
7 **beneficial to the Tohono O'Odham Nation and its people;**
8 **and**

10 **WHEREAS, 25 CFR 271.20 of the Code of Federal Regulations**
11 **requires that all proposals to recontract under P. L.**
12 **93-638 be submitted to the Tohono O'Odham Legislative**
13 **Council for approval at least 120 days prior to the**
14 **current contract termination; and**

17 **WHEREAS, the Tohono O'Odham Nation does desire to recontract**
18 **for provision of services during FY 1995; and**

19 **WHEREAS, the Tohono O'Odham Legislative Council has reviewed**
20 **and approved the FY 1995 Higher Education Program**
21 **recontract proposal and budget.**

23 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham**
24 **Legislative Council that it does authorize and request**
25 **the Bureau of Indian Affairs to recontract with the**
26 **Tohono O'Odham Nation under P. L. 93-638 regulations**

9 **BE IT FURTHER RESOLVED** by the Tohono O'Odham Legislative
10 **Council that the Tohono O'Odham Nation will not fund**
11 **or operate the program in the interim while**
12 **negotiations are still being conducted and no executed**
13 **contract has been approved by the Bureau of Indian**
14 **Affairs, unless the agency authorizes and approves pre-**
15 **award costs consistent with the Indian Self-**
16 **Determination Act, as amended and relevant contract**
17 **regulations.**

20 **BE IT FURTHER RESOLVED** by the Tohono O'Odham Legislative
21 **Council that the Tohono O'Odham Nation's Officials, to**
22 **wit: the Chairman and any designated official are**
23 **hereby authorized to negotiate and execute the contract**
24 **provided however, that any amendments affecting the**
25 **funding or funding levels of the contract shall be**
26 **submitted for further prior approval by this Council.**


