3 **WHEREAS, the Tohono O'Odham Nation is presently operating the**
4 **Employment Assistance Readiness Network (EARN)**
5 **Program under FY 1994 P. L. 93-638 contract with the**
6 **Bureau of Indian Affairs; and**

8 **WHEREAS, such tribal operations have been successful and**
9 **beneficial to the Tohono O'Odham Nation and its people;**
10 **and**

12 **WHEREAS, 25 CFR 271.20 of the Code of Federal Regulations**
13 **requires that all proposals to recontract under P. L. 93-**
14 **638 be submitted to the Tohono O'Odham Legislative**
15 **Council for approval at least 120 days prior to the**
16 **current contract termination; and**

18 **WHEREAS, the Tohono O'Odham Nation does desire to recontract**
19 **for EARN initiatives during Fiscal Year 1995; and**

21 **WHEREAS, the Tohono O'Odham Legislative Council has reviewed**
22 **and approved the FY 1995 Employment Assistance**
23 **Readiness Network contract proposal and budget.**

25 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham**
26 **Legislative Council that it does authorize and request**
27 **the Bureau of Indian Affairs to recontract with the**
28 **Tohono O'Odham Nation under P. L. 93-638 regulations**

7 **commence on October 01, 1994 through September 30,**
8 **1995.**

10 **BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative**
11 **Council that the Tohono O'Odham Nation will not fund**
12 **or operate the program in the interim while**
13 **negotiations are still being conducted and no executed**
14 **contract has been approved by the Bureau of Indian**
15 **Affairs, unless the agency authorizes and approves pre-**
16 **award costs consistent with the Indian Self-**
17 **Determination Act, as amended and relevant contract**
18 **regulations.**

21 **BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative**
22 **Council that the Tohono O'Odham Nation's Officials, to**
23 **wit: the Chairman and any designated official are**
24 **hereby authorized to negotiate and execute the contract**
25 **provided however, that any amendments affecting the**
26 **funding or funding levels of the contract shall be**
27 **submitted for further prior approval by this Council.**




