

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY 1995 Management of Health Services Recontract Proposal)**

RESOLUTION NO. 94-195

WHEREAS, the Tohono O'Odham Nation is presently operating the Management of Health Services under FY 1994 P. L. 93-638 contract with the Public Health, Indian Health Services; and

WHEREAS, 42 CFR 36.205 of the Code of Federal Regulations requires that all proposals to recontract under P. L. 93-638 be submitted to the Tohono O'Odham Legislative Council for approval at least 120 days prior to the current contract termination; and

WHEREAS, the Tohono O'Odham Nation does desire to recontract for provision of services during FY 1995; and

WHEREAS, the Tohono O'Odham Legislative Council has reviewed and approved the Management of Health Services FY 1995 contract proposal and budget.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council that it does authorize and request the Public Health, Indian Health Service to recontract with the Tohono O'Odham Nation under P. L. 93-638 regulations and procedures for the provision of services titled: Management of Health Services.

6 **BE IT FURTHER RESOLVED** by the Tohono O'Odham Legislative
7 Council that the Tohono O'Odham Nation will not fund
8 or operate the program in the interim while
9 negotiations are still being conducted and no executed
10 contract has been awarded by the Indian Health Service,
11 unless the agency authorizes and approves pre-award
12 costs consistent with the Indian Self-Determination Act,
13 as amended and relevant contract regulations.

16 **BE IT FURTHER RESOLVED** by the Tohono O'Odham Legislative
17 Council that the Tohono O'Odham Nation's Officials, to
18 wit: the Chairman and any designated official are
19 hereby authorized to negotiate and execute the contract
20 provided however, that any amendments affecting the
21 funding or funding levels of the contract shall be
22 submitted for further prior approval by this Council.


