

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY 1995 Tuberculosis Control Program Proposal)**

3 **WHEREAS, the Tohono O'Odham Nation has operated a**
4 **Tuberculosis Control Program to help prevent the**
5 **spread of the disease through community education,**
6 **prevention, early detection, comprehensive regimens**
7 **and careful follow up with individuals; and**

9 **WHEREAS, funding for the operation of the Tohono O'Odham**
10 **Tuberculosis Control Program has been provided in part**
11 **through supplemental funding sources; and**

13 **WHEREAS, the Tohono O'Odham Tuberculosis Control Program**
14 **desires to continue the services it provides to TB**
15 **susceptible patients; and**

17 **WHEREAS, the Tohono O'Odham Tuberculosis Control Program has**
18 **received funding from the State of Arizona, Department**
19 **of Health Services for its program.**

21 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham**
22 **Legislative Council that it hereby approves the proposal**
23 **for funding of the Tohono O'Odham Tuberculosis**
24 **Control Program from the State of Arizona, Department**
25 **of Health Services.**

27 **BE IT FURTHER RESOLVED that the duration of this contract will be**
28 **from July 01, 1994 through June 30, 1995 unless extended**

by mutual agreement of both contracting parties.

BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation will not fund or operate the program in the interim while negotiations are still being conducted and no executed contract has been awarded by the State of Arizona.

BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation's Officials, to wit: the Chairman and any designated official are hereby authorized to negotiate and execute the contract provided however, that any amendments affecting the funding or funding levels of the contract shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 6TH. day of JUNE, 1994 at a meeting at which a quorum was present with a vote of 1,763.0 FOR; -0- AGAINST; -0- NOT VOTING; and 03 ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
