**WHEREAS, the Tohono O'Odham Nation is presently operating the
Law Enforcement and Detention Services/Anti-Drug
Program under FY 1994 P. L. 93-638 contract with the
Bureau of Indian Affairs; and**

**WHEREAS, such tribal operations have been successful and
beneficial to the Tohono O'Odham Nation and its people;
and**

**WHEREAS, 25 CFR 271.20 of the Code of Federal Regulations
requires that all proposals to recontract under P. L. 93-
638 be submitted to the Tohono O'Odham Legislative
Council for approval at least 120 days prior to the
current contract termination; and**

**WHEREAS, the Tohono O'Odham Nation does desire to recontract
for provision of services during FY 1995; and**

**WHEREAS, the Tohono O'Odham Legislative Council has reviewed
and approved the FY 1995 Law Enforcement and
Detention Services/Anti-Drug Program contract proposal
and budgets.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham
Legislative Council that it does authorize and request
the Bureau of Indian Affairs to recontract with the**

Tohono O'Odham Nation under P. L. 93-638 regulations and procedures for the provision of services titled: Law Enforcement and Detention Services.

BE IT FURTHER RESOLVED that the duration of this contract shall commence on October 01, 1994 through September 30, 1995.

BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation will not fund or operate the program in the interim while negotiations are still being conducted and no executed contract has been approved by the Bureau of Indian Affairs, unless the agency authorizes and approves pre-award costs consistent with the Indian Self-Determination Act, as amended and relevant contract regulations.

BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation's Officials, to wit: the Chairman and any designated official are hereby authorized to negotiate and execute the contract provided however, that any amendments affecting the

funding or funding levels of the contract shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 7TH day of JUNE, 1994 at a meeting at which a quorum was present with a vote of 1,763.0 FOR; -0- AGAINST; -0- NOT VOTING; and 03 ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
