RESOLUTION NO. 94-203

**WHEREAS, the Job Training Partnership Act was enacted into law in
1982 replacing CETA; and**

**WHEREAS, funding is made available to State and Tribal
Governments to establish programs for improving the
employment prospects of eligible persons through
designation of service delivery areas; and**

**WHEREAS, the State of Arizona is entitled to JTPA funds to develop
a network of employment training programs throughout
the State; and**

**WHEREAS, Indian Reservations in Arizona have been designated as
service delivery areas and are eligible to receive State
JTPA funds; and**

**WHEREAS, the JTPA Program submits the following documents for
review and approval for the Title IIA Contract Proposal
for Fiscal Year 1995:**

- 1. Fiscal Year 1995 Administrative Cost Pool Budget
reflecting the final allocation in the amount of
\$21,319.00; and**
- 2. Fiscal Year 1995 Program Budget reflecting the final
allocation of \$113,704.00.**

For a grand total amount of \$135,023.00.


21 **The foregoing Resolution was passed by the Tohono O'Odham**


