3 **WHEREAS, the Tohono O'Odham Nation is presently operating the**  
4 **Psychological Services - Children's Initiative Component**  
5 **under FY 1994 P. L. 93-638 contract with the Public**  
6 **Health, Indian Health Services; and**

8 **WHEREAS, 42 CFR 36.205 of the Code of Federal Regulations**  
9 **requires that all proposals to recontract under P. L.**  
10 **93-638 be submitted to the Tohono O'Odham Legislative**  
11 **Council for approval at least 120 days prior to the**  
12 **current contract termination; and**

15 **WHEREAS, the Tohono O'Odham Nation does desire to recontract**  
16 **for provision of services during FY 1995; and**

17 **WHEREAS, the Tohono O'Odham Legislative Council has reviewed**  
18 **and approved the FY 1995 Psychological Services -**  
19 **Children's Initiative Component recontract proposal and**  
20 **budgets.**

22 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham**  
23 **Legislative Council that it does authorize and request**  
24 **the Public Health, Indian Health Service to recontract**  
25 **with the Tohono O'Odham Nation under P. L. 93-638**  
26 **regulations and procedures for the provision of services**  
27 **titled: Psychological Services.**

**BE IT FURTHER RESOLVED that the duration of this contract shall commence on October 01, 1994 through September 30, 1995.**

**BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation will not fund or operate the program in the interim while negotiations are still being conducted and no executed contract has been approved by the Indian Health Service, unless the agency authorizes and approves pre-award costs consistent with the Indian Self-Determination Act, as amended and relevant contract regulations.**

**BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation's Officials, to wit: the Chairman and any designated official are hereby authorized to negotiate and execute the contract provided however, that any amendments affecting the funding or funding levels of the contract shall be submitted for further prior approval by this Council.**
