certified public accounting firms with knowledge and familiarity of tribally-owned farming operations; and WHEREAS, the Agriculture Committee recommends the appropriation of funding to engage the firm of Eide Helmeke & Co., Certified Public Accountants & Consultants, to perform the operations audit of the Farming Authority in accordance with the March 27, 1994 proposal submitted by Eide Helmeke, a copy of which is attached hereto and incorporated herein by reference.

NOW, THEREFORE, BE IT RESOLVED THAT:

- The Legislative Council approves engaging the firm of Eide Helmeke & Co., Certified Public Accountants & Consultants, to perform the operations audit of the Farming Authority in accordance with the March 27, 1994 proposal submitted by Eide Helmeke, a copy of which is attached hereto and incorporated herein by reference.
- 2. The Legislative Council authorizes the appropriation of the sum of \$18,000 from the Nation's General Reserve Account for purposes of funding the contract with Eide Helmeke & Co.
