3 **WHEREAS, the Tohono O'Odham Utility Authority (TOUA) proposes**  
4 **to construct a new water line extension to furnish water**  
5 **facilities and other related utility services for home sites**  
6 **in the San Xavier Community/district, and has submitted**  
7 **a plat or map thereof to the Tohono O'odham Legislative**  
8 **Council showing the location and scope of the easement**  
9 **and delineating the utility facilities to be placed thereon;**  
10 **the length of easement in the San Xavier Community is**  
11 **578.00' X 20' wide was set forth on the attached drawings;**

15 **WHEREAS, the Tohono O'odham Legislative Council has determined**  
16 **that the routing and location of the easement for the**  
17 **water line extension and other utility services is not in**  
18 **conflict with any land use plans adopted by the District**  
19 **Council and approved by the Tohono O'odham**  
20 **Legislative Council, and that the new water line**  
21 **extension will be of substantial benefit to the San Xavier**  
22 **Community, District, the Tohono O'odham Nation and to**  
23 **their respective members.**
