**RESOLUTION NO. 94-235**

**WHEREAS, the Tohono O'Odham Legislative Council by Resolution  
No. 92-171, recognized the Tohono O'odham Nation  
Cultural Exchange Youth (TONCEY) as a delegation of the  
Nation as "Cultural Emissaries of the Tohono O'odham  
Nation"; and**

**WHEREAS, the Tohono O'odham Legislative Council's Cultural  
Preservation Committee has requested the TONCEY to  
accept the invitation extended from the Association for  
International Cultural Programs to represent the Native  
Americans of the Continental United States in the  
Opening Ceremonies of the Goodwill Games being held  
in Kirov Stadium, St. Petersburg, Russia; and**

**WHEREAS, the TONCEY continues to provide the youth in promoting  
the O'odham Culture and enables them to experience  
cultural awareness with other nationalities of the world;  
and**

**WHEREAS, the TONCEY have been raising funds for their trip to St.  
Petersburg, Russia but are in further need of monetary  
assistance in the amount of \$55,661.90.**



**BE IT FURTHER RESOLVED that the \$55,661.90 will be appropriated out of the General Revenues account of the Nation.**

**The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 10TH day of JUNE, 1994 at a meeting at which a quorum was present with a vote of 1,687.0 FOR; -0- AGAINST; 75.5 NOT VOTING; and 06 ABSENT, pursuant to the powers vested in the Council by Section 1(d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


