**RESOLUTION NO. 94-252**

**WHEREAS, the Tohono O'Odham Legislative Council did by  
Resolution No. 94-246 reject the San Xavier Mediation  
Proposal Related to Water Resource Disputes Between  
the Nation and Allottees ; and**

**WHEREAS, upon presentation of Resolution No. 94-246 to the  
Chairman of the Tohono O'odham Nation, he did  
disapprove thereof and returned it to the Council with  
his objections in accordance with the provisions of  
Article VII, Section 5 of the Constitution of the Tohono  
O'odham Nation; and**

**WHEREAS, the Tohono O'Odham Legislative Council has reviewed  
the Chairman's objections and after consideration,  
again voted to pass Resolution No. 94-246 .**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham  
Legislative Council does hereby override the Chairman's  
veto of Resolution No. 94-246 by a vote of two-thirds of  
the votes cast.**

**The foregoing Resolution was presented to the Tohono O'Odham  
Council on the 11TH. day of JULY, 1994 at a meeting at which a  
quorum was present and, by a vote of 1,324.0 FOR; 315.0 AGAINST;  
124.0 NOT VOTING; and 02 ABSENT, was passed by a majority of at  
least TWO-THIRDS (2/3) 1,093.0 of the votes cast and became law as**




